VisiSpecs user licenses are just \$139/user/month for most implementations and as little as \$59 for very small firms. **Company Edition** is the **standard price point** and includes all functionality as well as the option for local server deployment, dedicated servers, and volume user and multi-year discounts.

**Starter Edition** is for startup firms and consultants requiring just 1 or 2 licenses of VisiWord for spec writing time savings and product quality improvements.

**Team Edition** is for small teams or deployments for up to 5 licenses and includes the VisiRevit and VisiWord functionality.

**Floating Licenses** are available instead of the Per Named User licenses for a 50% uplift. Floating Licenses (aka Network Concurrent Use Licenses) offer flexibility, ease of deployment, and ease of use enabling many more company employees to install, register, use, and benefit from VisiSpecs. Floating licenses may also be reserved for specific users who always need a license available.

## Notes:

A Corporate Account may contain one or more active user licenses, all in same Edition (Starter, Team, or Company) and having the same expiration.

A Per User license is for an individual named user to login and access VisiSpecs project data. Floating licenses are shared by all Corporate Account users.

A Corporate Account can have Per Named User Licenses OR Floating Licenses (not a mix of the two).

Monthly subscriptions require an initial two month subscription on the initial order.

An expired or disabled user account will not be able to login to VisiSpecs until they become an active licensed user.

An expired account is maintained in the VisiSpecs Cloud and available for renewing your subscription or Customer may delete all data.

Starter and Team Edition Subscriptions get annual rate with existing licenses extended and prorated to expire on the same date.

Company Edition Subscriptions may add additional licenses at annual rate for less than 12 months to expire with current subscription.

Local Server and Dedicated Server options have a minimum license order plus services fees. Consult us for more information.

Multi-Year Discounts paid up front are 5% for 2 years, 7.5% for 3 years, and 10% for 4 years.

Volume Discounts are 5% for 10+ users, 10% for 20+ users, and 15% for 40+ users on the same purchase order on annual subscriptions only.
